### IN OHIO, ED FITZGERALD TRAILS IN POLLS WHILE HIS CAMPAIGN STRUGGLES TO ADDRESS CONTROVERSIES

**According To A Quinnipiac Poll, County Executive Ed FitzGerald (D-OH) Trails Governor John Kasich (R-OH) By 12 Points.** "Cuyahoga County Executive Ed FitzGerald, the Democratic challenger in the race for Ohio governor, remains largely unknown and is gaining little ground against Republican Gov. John Kasich who leads 48 - 36 percent, according to a Quinnipiac University poll released today." John Kasich. The Democratic nominee still has a long way to go with little more than three months until Election Day,' said Peter Brown, assistant director of the Quinnipiac University Poll. 'Almost two-thirds of registered voters don't know enough about FitzGerald to have an opinion of him. That's an awful lot of Ohioans who still have to be introduced to him. This survey was conducted during the period in which the Democrat had just begun his television advertising buy.'" ## IN ARKANSAS, MIKE ROSS TRAILS ASA HUTCHINSON FOR THE FIFTH STRAIGHT POLL AS THE RACE MOVES TO “LEAN REPUBLICAN”

**According To A Recent Talk Business & Politics-Hendrix College Survey, Republican Asa Hutchinson Holds A Five-Point Lead Over Former Rep. Should Hutchinson win, it would mark a turnover from the Democrats as incumbent Gov. Mike Beebe (D) is term-limited. Arkansas has moved very sharply toward Republicans in recent years at the federal level, though Sen. Mark Pryor (D) is trying to buck this trend in the state’s Senate race this cycle. But the GOP has also made significant gains at the state level, taking full control of the state legislature in 2012 for the first time since Reconstruction. Pat Quinn's aides sought to pump up an anti-violence program ahead of his November 2010 election bid, they decided to add to the pot \$3.76 million in federal disaster recovery funds from Hurricane Ike to make loans to small businesses. In the rush to get the program launched, the Quinn administration hired a financially troubled West Side business development group to dole out loans, despite concluding the organization had recently misspent state grant funds. The group, Chicago Community Ventures, did not make a single loan but was allowed to keep more than \$150,000 when the contract was nixed, the Tribune has found." Pat Quinn (D), barely elected to his first full term in 2010 and hampered by a poor state economy and budget problems, appears to be losing so far to a wealthy Republican, Bruce Rauner. ... While this race could well shift again this cycle, we're now moving it from Toss-up to Leans Republican. We've heard a lot of pessimism from Democrats about Quinn's odds, though they hold out hope that he can pull the rabbit out of a hat once again. He might, but he's down right now — and facing a better candidate, Rauner, than he did last time. According to Politico's Kyle Cheney, Quinn would be the first governor from the president's home state (and of the president's party) to lose reelection since 1892." (Larry J. **IN HAWAII, EVEN WITH OBAMA'S SUPPORT, NEIL ABERCROMBIE'S CAMPAIGN IS IN JEOPARDY**

**According To A *Honolulu Star-Advertiser* Poll, Gov. Neil Abercrombie (D-HI) Trails His Democratic Primary Opponent, State Sen. David Ige (D-HI), By 18 Points With Less Than A Week Until The Primary.** "Neil Abercrombie is in grave risk of losing to state Sen. David Ige in the Democratic primary, according to a new Hawaii Poll that shows the governor's job approval and favorability sinking among voters. Ige, chairman of the Senate Ways and Means Committee, holds a 54 percent to 36 percent lead over Abercrombie with 11 percent undecided. No governor has lost re-election since William Quinn, a Republican, in 1962, so Ige could be on the cusp of a historic upset on Saturday. Forty-six percent of voters who said they were voting for Ige were doing so primarily because they do not like the governor, a sobering verdict for the incumbent." **Sabato Recently Moved The Hawaii Governor's Race From "Leans Democrat" to "Toss-Up."** "Hawaii: Gov. Neil Abercrombie (D) is so personally unpopular that he will be lucky to survive the Democratic primary against state Sen. David Ige. In fact, Democratic pollster Public Policy Polling recently found Ige leading Abercrombie 49%-39%, though any survey in the notoriously-difficult-to-poll Aloha State must be treated with caution. That said, we're hearing that the public polls in Hawaii might not be far off the

mark, and that Abercrombie is in real trouble heading into the Saturday, Aug. 9 primary. Even if Abercrombie wins renomination, he may well falter in the general election matchup against his 2010 general election opponent, former Lt. Gov. Duke Aiona (R). Moreover, the independent candidacy of former Honolulu mayor Mufi Hannemann, an ex-Democrat, will further complicate things. This race shifts from Leans Democratic to Toss-up, and the primary is a Toss-up, too.” (Larry J. Triz delaRosa, Bruce Goldberg, Aaron Karjala, Rocky King and Carolyn Lawson have applied for legal coverage under a new state policy adopted as a result of the ongoing FBI investigation, according to documents obtained by The Oregonian. The policy pays up to \$35,000 for the legal defense of a current or former state employee accused of a crime." This is why Democratic gubernatorial nominee Wendy Davis should voluntarily disclose the names of the roughly 100,000 donors who have made small contributions to her campaign. They have donated \$3.25 million of her \$27 million total ... Transparency is about doing the work of democracy, lending it credibility because all cards on the table get shown.
